Welcome to the "Funding Finder" grant book compiled by the USTA Intermountain Community Development Committee. This grant book touches the tip of the iceberg when it comes to the multiple grant opportunities, non-tennis specific, that are out there in the Intermountain Section and nationally.

The Community Development Committee embarked on this project in an effort to meet the needs of community tennis associations (CTAs) around the section whose main request is "FUNDING." While we at the USTA Intermountain Section would love to be able to hand out funding to all of the well deserving CTAs in our section, that just isn't feasible. So, we did the only thing that we could do -- we researched grant opportunities for you.

We have researched state-specific grants and foundations along with national grants/foundations that we feel could apply to CTAs, depending on your focus and mission. This manual begins with a listing of national grants and follows with grants offered to organizations in Colorado, Idaho, Montana, Nevada, Utah and Wyoming. The information on each grant includes: a description of the grant, requirements to be eligible to receive a grant, amount of the grant, deadline for the grant (this is subject to change as this publication was first published in 2003 and has most recently been updated in September 2007 - deadlines will most likely change from year to year so it is up to the applicant to obtain the most recent deadline for a particular grant), a contact and address, and a website (when applicable). Keep in mind that this information may change from year to year so you might need to do some research of your own to get updated information on the grants listed within.

As mentioned above, this is only a small fraction of the grants/foundations that exist that may benefit your organization. We encourage you to sift through these pages and see if any of these grants would be applicable to and benefit your organization. In addition, you might want to do some research of your own because there are many other opportunities out there. For example, each state receives federal funding due to the Federal Land & Water Conservation Fund. We encourage you to contact your local government agencies and tap in to this funding.

We hope this is a useful tool for you as you attempt to grow and develop your organization. Happy funding hunting!

Leadership for a Changing World

Description: to recognize, strengthen, and support leaders and to highlight the importance of community leadership in improving people's lives. The program recognizes leaders and leadership teams (of no more than four members) not well-known outside their community or field. Nominees may work in fields such as economic or community development, environment and environmental justice, human rights, citizen participation and government accountability, human development, sexual and reproductive health, education reform, youth development, religion and social change, arts and social action, and access to media. Awards support recipients' programs or new work related to the programs for which recipients are recognized.

Qualifications: community leaders in the U.S. who are working on social justice issues.

Nominations must be made by someone who is well-acquainted with the nominated leader or leadership group and can demonstrate their qualifications, but is not a family member, board or staff member, or consultant for the nominee's organization.

Wyoming State Parks and Historic Sites, Land & Water Conservation Fund

Description: the successful grant applicant must agree to dedicate the project for use by the public for perpetuity. The project must also be maintained at acceptable National Park Service standards for public outdoor recreation. All applications must meet a State Comprehensive Outdoor Recreation Plan identified need and then ranked by the Open

Project Selection Process. Only costs for the development and/or acquisition of public outdoor recreation lands and facilities are eligible for assistance. The project should be designed for seasonal usage, provide multiple use outdoor recreational activities, exhibit a high level of volunteerism, include local cash donations or cooperation by service organizations. Also the project should be located within a park. If the application is for the continuation of a previously constructed recreational park area this project will serve to enhance the area. The applicant has coordinated this project with other public or private agencies providing for joint use and or funding of facilities.

Qualifications: The Land and Water Conservation Fund Act provides for grants only to states and through them to their political subdivisions. This grant is to be used in conjunction with your City Recreation Department or School District. Project sponsors such as cities, towns, counties, school and recreation districts are eligible to apply for L&WCF monies. The L&WCF is a matching grant program based upon a 50% reimbursement of the total cost of the project.

Amount of Grant: grants have ranged from \$44,550 + \$374,550 from the University of WY for development of their park project; \$3,375 + \$25,000 from the town of Sheridan for resurfacing of Kendrick Park Tennis Courts; \$6,129 + \$45,400 from the town of Hulett for Town Park Improvement; and \$20,250 + \$170,250 from the town of Afton for the Allred Lane Recreation area improvements.

Deadline: grant applications must be postmarked no later than January 30, 2004.
