

# **LOCAL GRIEVANCE COMPLAINT (04)**

**2.02A(1)** All complaints alleging a violation of the USTA Constitution, By-Laws or Standing Orders; the USTA Tournament Regulations or other USTA regulations (unless modified by these USA LEAGUE TENNIS REGULATIONS); the USA LEAGUE TENNIS REGULATIONS or standards of good conduct, fair play and good sportsmanship, shall be filed in writing with the USA League Tennis Grievance Committee responsible for enforcement.  
**2.02A(4)** All complaints shall be filed against the player or team complained against, (a) by the team captain of the team who has competed in the match where the alleged violation occurred, (b) by a league coordinator or (c) by a member of a championships committee.

**2.02B(1)** All complaints alleging a violation during local league competition shall be filed in writing with the chairman of the Local League Grievance Committee prior to the commencement of the next team match involving such player or team, or within twenty-four hours after the end of local league play, whichever occurs first.

**2.02B(2)** At the time a complaint is filed, a copy of such complaint shall be sent to the party(ies) against whom the complaint has been made.

**2.02B(3)** A complaint regarding failure to meet eligibility requirements (e.g. under age, not a USTA member) may be filed by a team captain or league coordinator at any time. A USA league coordinator may declare a player ineligible and disqualify that player without filing a grievance prior to the disqualification. (See 1.10, 3.01C, 3.01D, 4.01, 5.01C and 5.01D.)
